Auszug aus Monthly Threat Report April 2024

- Die Anzahl der Low-Effort-/High-Volume-Angriffe per E-Mail hat im ersten Quartal zugenommen, vermutlich begünstigt durch die zunehmende Nutzung generativer KI von Cyberkriminellen.
- PDF-, Archiv- und HTML-Dateien waren die drei Dateitypen, die im ersten Quartal am häufigsten zur Verbreitung schädlicher Nutzdaten verwendet wurden.
- DocuSign, DHL und PayPal waren im ersten Quartal die am häufigsten imitierten Marken.
- Der Einsatz von KI-Tools zur Erstellung ganzer Phishing-Kits ist nach wie vor ein unglaublich einfaches Unterfangen.



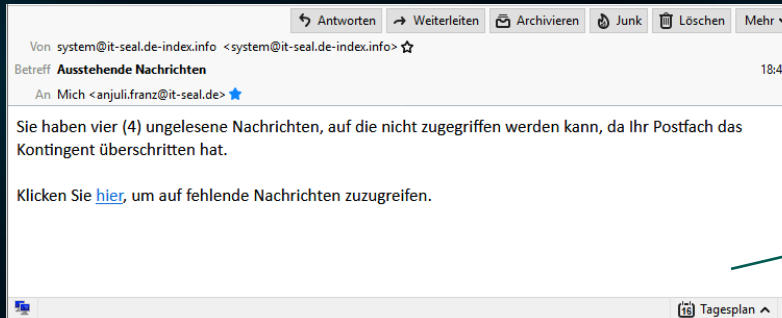

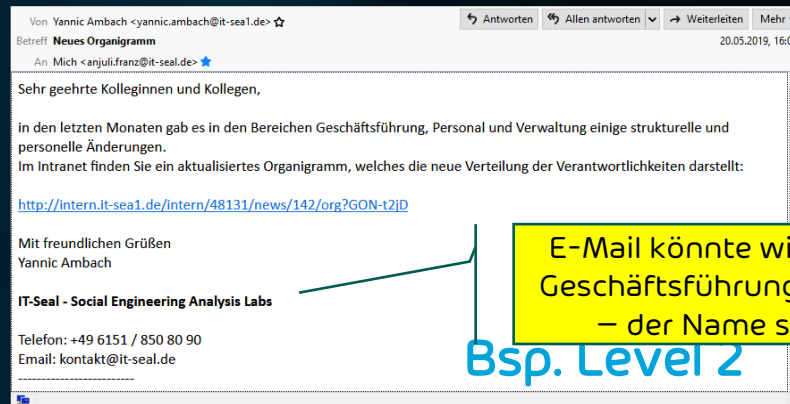

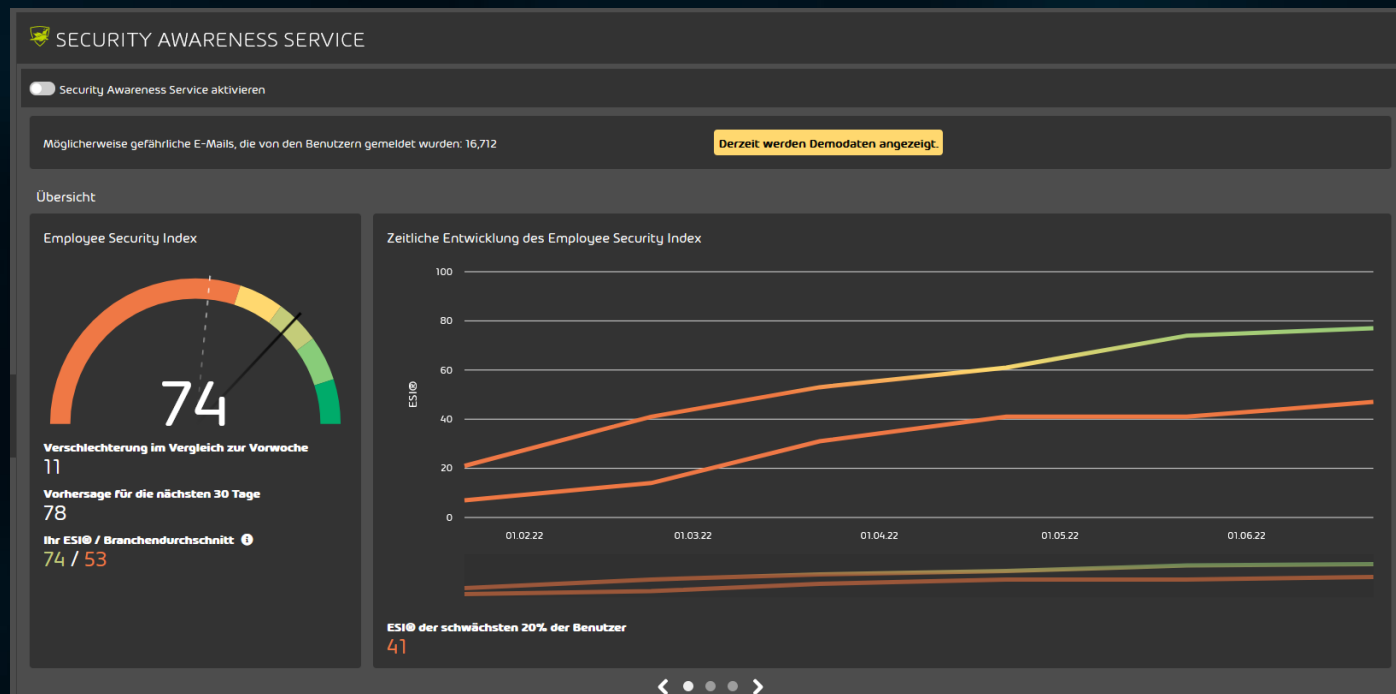

WOZU BRAUCHEN SIE 365 PERMISSION MANAGER?

- Zugriffsberechtigungen nehmen immer zu, aber niemals ab!
 - Kein Benutzer öffnet Microsoft Teams und sagt, *"Wir arbeiten doch gar nicht mehr mit diesem Freelancer zusammen, lass uns seinen Zugriff entfernen!"*



- Die Audits werden nie von den Personen durchgeführt, die die Daten und den darauf gewährten Zugriff verstehen!
 - Kein CISO weiß, welcher externe Benutzer Zugriff auf was benötigt, und bei Hunderten von Freigaben pro Tag *sind gewöhnliche Audits innerhalb weniger Stunden veraltet!*



- M365 verfolgt beim Umgang mit Freigabeberechtigungen einen Alles-oder-Nichts-Ansatz, der völlig unrealistisch ist.
 - Admins sind gezwungen, die Kontrolle den Nutzern zu überlassen, damit ist es nur eine *Frage der Zeit, bis kritische Daten nach außen dringen!*

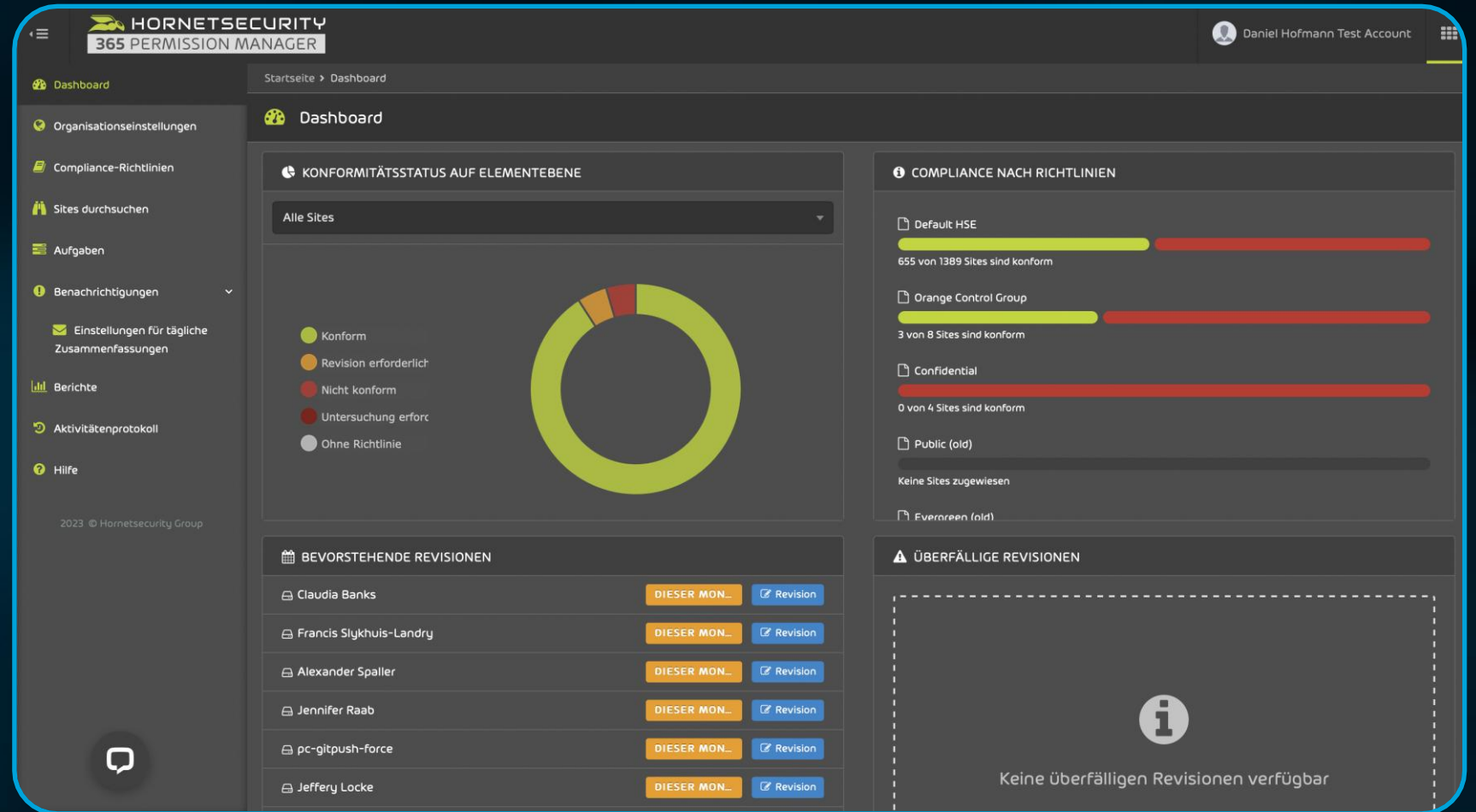
